Re: Proposed initial public offering of equity shares of face value of ₹2 each (the "Equity Shares") of Transrail Lighting Limited (the "Company" and such offering, the "Fresh Issue") and an offer for sale of Equity Shares by certain existing shareholders of the Company (the "Offer for Sale", and together with the Fresh Issue, the "Offer")

We, Mehta & Mehta, are independent practicing Company Secretaries, holding a valid certificate of peer review bearing number 3686/2023 issued by the Peer Review Board of the Institute of Company Secretaries in India, which is valid as on date of this Certificate and is attached herewith as Annexure A.







We are appointed vide letter dated 06 February, 2024 to conduct a search (physical and digital) with respect to the (i) [company law records, resolutions, registers, secretarial and other statutory records, forms, deeds, returns and other documents] ("Corporate Records") in relation to the disclosure in the "Capital Structure" sections of the Offer Documents (defined below) of Transrail Lighting Limited filed with the office of Registrar of Companies, Maharashtra at Mumbai ("RoC") under the Companies Act, 2013 and rules made thereunder, since its incorporation.

For the purposes of issuing this certificate, we have carried out an in-depth review of the Corporate Records as provided by the Company officials in the following manner:

 Secretarial records maintained by the Company at the registered office, corporate office, or any other office or premises of the Company;

(ii) Documents available in the digital records/ database maintained on the Ministry of Corporate Affairs

portal as on the date of this certificate ("MCA Portal");

(iii) Physical search of the Corporate Records of the Company as maintained at the office of the RoC, the Registered Office of the Company, and other any other office or premises of the Company where such records were maintained since the incorporation of the Company and other designated premises;

(iv) the minutes of the meetings of Board of Directors of the Company, relevant statutory registers, financial statements, Memorandum of Association and Articles of Association and such other

documents as we deemed necessary at the Company Offices; and

(v) List maintained by the RoC in accordance with the Disposal of Records (in the Offices of the Registrars of Companies) Rules, 2003 in relation to the Corporate Records which have been disposed of.

Basis our in-depth search and inspection of the Corporate Records basis the procedure mentioned above, we enclose the following:

- (i) Annexure B: Summarizing the build-up of the share capital of the Company issued by the Company and details of the build-up of Promoters' shareholding in the Company, since its incorporation;
- (ii) Annexure C: Details of all acquisitions of securities of the Company through secondary transactions;

Further, pursuant to the review of documents, as specified above, we hereby confirm as under:

(i) The issuances and allotments by the Company since inception till the date of this certificate, have been issued and allotted in compliance with (a) the provisions of Companies Act, 1956, including sections 67 and 81 thereof and the rules made thereunder, as applicable; and (b) the provisions of the Companies Act, 2013, as applicable, including Sections 25, 28, 42 and 62 of the Companies Act, 2013, as applicable and the rules thereunder.(refer note below)

 the Company has passed all required resolutions and made the required form filings and submissions, including those to the RoC, and we have reviewed copies of such form filings and submissions; and

(iii) application monies have been received (in case of private placement or a preferential issue of Equity Shares in a separate bank account in accordance with applicable law) for all allotment of Equity Shares made by the Company.

(iv) We further confirm that there have been no instances of issuance of equity shares in the past by the Company

and its subsidiary to more than 49 persons / 200 persons, as applicable, in violation of:

a) Section 67(3) of the Companies Act, 1956;

b) relevant sections of the Companies Act, 2013, including Section 42 and the rules notified thereunder;
c) the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements)
Regulations, 2009 or the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements)
Regulations, 2018, each as amended, as applicable; or

d) the Securities and Exchange Board of India (Disclosure and Investor Protection) Guidelines,

2000, as applicable.

(v) The shareholders of the Company have not exceeded the limit of 49/200 in any of the financial years since inception.

Note: the Company vide board resolution dated September 9, 2024, approved an allotment of 1,033,057 Equity Shares at a price of ₹484.00 per Equity Share, aggregating to ₹500.00 million, to four allottees through private placement. Mr. Divyam Sanjay Agrawal, being one of the allottees, was required to remit an amount of ₹5.00 million from his personal bank account towards the share application money for the allotment of 10,333 Equity Shares, under such private placement. However, due to technical difficulties in transferring the required funds Divyam



Sanjay Agrawal requested M/s. Sanvijay Rolling and Engineering Limited to transfer such amount on his behalf to the Company. The Company took a declaration from Sanvijay Rolling & Engineering Limited and confirmation to that effect from Mr. Divyam Sanjay Agarwal that the money belongs to him. Consequently, the Company received the share application money for the allotment from M/s. Sanvijay Rolling and Engineering Limited and made the allotment of 10,333 Equity Shares to Divyam Sanjay Agrawal, in contravention of Rule 14(5) of the Companies (Prospectus and Allotment of Securities) Rules, 2014, as amended. The Company filed an adjudication application dated September 27, 2024, with the Registrar of Companies, Maharashtra at Mumbai ("RoC"), under Section 454 of the Companies Act, 2013, for adjudication of penalty for contravention of provisions of Section 42 of the Companies Act, 2013 along with Rule 14 of the Companies (Prospectus and Allotment of Securities) Rule, 2014, each as amended. The Company has received a show cause notice dated October 1, 2024, from the RoC, imposing a penalty of ₹240.00 million on the Company, its Promoters and Directors, under section 42(10) of the Companies Act, 2013, as amended ("SCN"). The Company has filed a reply dated October 15, 2024, to the SCN, before the RoC. Subsequently, the Company received an order dated October 29, 2024, for adjudication of penalty under Section 454 of the Companies Act, 2013, for violation of Section 42(10) of the Companies Act, 2013 ("Order") from the RoC. The Order imposed a penalty of ₹5.00 million on the Company, Digambar Chunnilal Bagde, Randeep Narang and Sanjay Kumar Verma, collectively. The penalty has been paid by the Company, Digambar Chunnilal Bagde, Randeep Narang and Sanjay Kumar Verma on 5th November, 2024.

We confirm that there are no findings/observations of any of the inspections by SEBI or any other regulator which are material, and which needs to be disclosed or non-disclosure of which may have bearing on the investment decision, other than the ones which have already disclosed in the Offer Documents.

Further, please note that the capital structure build-up of the Company is accurate, complete and in accordance with applicable law.

We hereby agree that the Book Running Lead Managers to the Offer the legal counsels to the Company and to the Book Running Lead Managers and any other third party related there to, appointed in connection with the proposed issue of securities by the Company pursuant to an initial public offer in India, may rely on the information provided in this report.
