Re: Intimation of certain delays and errors in form filings of Transrail Lighting Limited (the "Company")

Re: Proposed initial public offering of equity shares of face value of ₹ 2 each (the "Equity Shares") of Transrail Lighting Limited (the "Company" and such initial public offering, the "Offer")

This is in relation to the email dated May 17, 2024 received from the Securities and Exchange Board of India ("SEBI") seeking clarifications in respect of certain disclosures in the draft red herring prospectus dated March 8, 2024 (the "DRHP") filed with the Securities and Exchange Board of India ("SEBI"), BSE Limited ("BSE") and the National Stock Exchange of India Limited ("NSE", together with BSE, the "Stock Exchanges"), which requires, *inter alia*, our Company to write to the Registrar of Companies, Maharashtra at Mumbai ("RoC") informing you about certain delays or errors in filing of corporate records by our Company, as disclosed in risk number 29 in the section titled "Risk Factors" of the DRHP.

In this regard, please note that certain form filings, as applicable, set out in **Annexure A**, of our Company were inadvertently filed with errors and there were some delays in filing these forms with the RoC, in the past. Our Company has obtained a certificate dated March 8, 2024, from independent practising company secretaries, Mehta & Mehta Company Secretaries ("PCS **Certificate**"), stating that: (a) an independent search/inspection was carried out for the documents available in the digital records maintained on the Ministry of Corporate Affairs portal at www.mca.gov.in ("MCA Portal"); and (ii) a review of the documents and records available with the Company, was undertaken. Basis the above, the PCS Certificate has verified that the form filings set out in **Annexure A**, have been filed with errors or inadvertent delays, as applicable.

Further, please also note the Company had allotted 90,000 equity shares of face value ₹ 10 each to Digambar Chunnilal Bagde on August 1, 2022, under the Transrail Lighting Limited Employee Stock Options Scheme, 2019, when he was not the promoter of the Company.

We request you to take the aforementioned matter on your record.

This letter shall be submitted with the SEBI and any other statutory or regulatory authority, as may be required, and may be available for public for inspection in connection with the Offer.

All the capitalized terms used but not defined herein shall have the same meaning as ascribed to them in the DRHP filed with SEBI.
